PLANNED ACTIVITIES

The overall purpose is to bring improved healthcare to an impoverished area of Mexico, whose residents cannot access needed care due to both distance and cost. The objectives of this grant are to:

- Bring operational three working areas (waiting room, general exam room, pharmacy) of a new health clinic building
- Order, purchase and install the furnishings and medical equipment needed for the clinic to open and begin servicing the community on a regular weekly schedule.

Note 1: Completing these three areas noted above will enable other treatment rooms of the clinic to be developed over time (as patients seen in those other rooms would benefit from a waiting room and a pharmacy).

Note 2: This grant includes certain medical equipment that will eventually be relocated into its own room of the clinic when feasible (example: dental room). Although some rooms will not be immediately ready for the equipment, the equipment will be fully utilized from the start in other rooms, and relocated once the remaining rooms are completed.

Note 3: This grant includes funding for the first six months of the clinic's operating expenses (budgeted at USD37,000). The clinic will initially operate a partial work week (1-3 days) until fully operational when it will be open Monday through Saturday. The clinic budget will be USD8,000 per month once it is fully operational.

The clinic will serve the residents of Renacimiento, as well as neighboring communities.

Renacimiento is located in the Garcia Municipality of the state of Nuevo Leon, Mexico.

SUSTAINABILITY

What community needs will your project address and how were these needs identified? Provide any relevant data or survey results

- * The clinic will serve 1,100 households (4,400 total population, mostly women and children)
- * Approximately 90% of the surrounding population has no access to health care except that which this clinic will provide.
- * The clinic will operate Mon-Friday and will be able to provide medical service to 30 people daily (dentistry, nutrition, psychology and opthalmology services)
- * The nearest hospital is approximately a one hour drive from Renacimiento.
- * There are two clinics within 6 kilometers of Renacimiento. One is a general practice/medicine clinic that is only available to individuals who have an affiliation /membership to the clinic. The other is a Red Cross emergency/urgent care clinic.
- * Because of Mexican legislation, the general practice clinic does not provide access to families of Renacimiento since the majority do not have a formal job.

Detail how your project will address these community needs.

- * This project addresses community needs by providing on site medical services which include primary pediatric services and evaluations with a future plan for dentistry, nutrition, psychology and opthalmology.
- * Initially the clinic will have capacity to provide services to 30 patients daily.
- * The goal for the clinic is top operate Monday Saturday to provide primary medical services (to include treatment for diabetes, hypertension and other conditions). A short-term future plan will include more thorough services including evaluations of laboratory data including anemia, electrolytes and cholesterol as well as pediatric evaluations and care.
- * The long term goal of the clinic is to offer dentistry, nutrition, psychology and opthalmology services.
- * Frequent medical brigades hosted by the clinic will provide medical services to another 150 200 people (anticipated 9 brigades per year).
- * The surrounding population of approximately 4,400 includes 1,100 households of mostly women and children
- * The expectation of the medical clinic is to serve those families located within a 5 square kilometer area. However, recent experience with the medical brigades care provided by volunteer doctors on a specified day, have shown folks as far away as 15 kilometers coming for care.
- * The clinic budget includes fee for service at the patient level, to be determined on a sliding scale basis, most likely in the US\$2-3 range. The clinic anticipates that approx. 8% of patients will not be able to pay a fee for services.

How were members of the local community involved in planning the project? Does your project align with any current or ongoing local initiatives?

*The Rotary Club of Sierra Madre has been aware of the clinic since late 2014 and have seen their progress over time and over several meetings during visits to our club when the project leaders shared their plan. Prior to these meetings the Rotary Club of Sierra Madre performed a review of community needs and after meeting the clinic representatives to better understand their commitment to the community, they agreed this cause would be the best use of efforts and a partnership with the clinic would best benefit the surrounding community.

There is a Board of Directors for the health clinic, and the individuals named below serve on that Board:

- * Casa Samuel A.C. is a qualified Mexican non-profit social services organization directed by Pastor Eva Zapata. It is a food bank for the hungry.
- * This area of Mexico has been visited by Marietta church youth on mission trips to build homes for the homeless, which will continue by Marietta Community Church (Collins Roux).
- * A qualified U.S. non-profit organization, MAC Ministries of Marietta, GA, directed by Pat MacPherson, has visited the area many times and established relationships with local churches and business organizations, including the CR of Sierra Madre.
- * Dr. Jesus Santos (Cardiologist & Professor at the Medical University of Monterrey) is the current Medical Director for the

Clinic, who will recruit both part-time and fulltime volunteer medical professionals to treat the clinic patients.

- * Roberto Garza is currently the Director of Operations for Casa Samuel Salud ABP. He will manage the use of the clinic and will oversee the staffing of the clinic (both paid and volunteer staff).
- *The City of Garcia owns the land upon which the medical clinic resides. Currently, the land is provided to Casa Samuel through a 15 year, no-cost grant. Negotiations are in progress to extend this grant to be a 99 year grant.
- * While some of the above sponsors have a religious affiliation, Clinica de Salud Casa Samuel will serve the needs of all who are in need of health care, without any restrictions placed upon the services provided.

Describe any training, community outreach, or educational programs, if applicable, and who will conduct them. How will recipients be selected?

Dr. Jesus Santos (Cardiologist & Professor at the Medical University of Monterrey), in conjunction with Robert Garza, will be managing the use of the clinic and will be overseeing the staffing and training of the clinic medical personnel (both paid and volunteer staff).

Areas of Focus

Disease prevention and treatment

Which goals will your activity support?

Improving the capacity of local health care professionals; Promoting disease prevention programs, with the goal of limiting the spread of communicable diseases and reducing the incidences of and complications from non-communicable diseases; Enhancing the health infrastructure of local communities; Educating and mobilizing communities to help prevent the spread of major diseases; Preventing physical disability resulting from disease or injury

How will you meet these goals?

The plan for the clinic is to have it open and ready for use by July, 2016. We anticipate that full equipping of the clinic will take up to 2 years; however, there are several local organizations/ministries/churches who are formally partnering with Casa Samuel Salud to help provide interim resources so health care can start being provided. To this point, Casa Samuel Salud has hosted 6 one-two day medical brigades (both medical and dental) where 100 - 200 people were seen at each brigade. The layout of the clinic is attached for ease of reference. All of the equipment funded by this grant will be put to immediate use, as the rooms are completed the equipment will be moved to its specific space. The clinic budget includes fee for service at the patient level, to be determined on a sliding scale basis, most likely in the \$2-\$3 range. The clinic anticipates that approximately 8% of patients will not be able to pay a fee for service.

The basement resides under the main level of the medical clinic. This space was added to help provide evacuation care to the community in response to natural disasters (i.e. victims of floods or fires). The space will also be used to serve the community such as medical brigades that will occur as part of the mission of the clinic.

The Sierra Madre Rotary club identified this community need with the help of another NPO. Once done we organized fund raising activities to fund the project and partnered with the Marietta Metro Rotary club to perform this grant request. We will also oversee the completion of the project and finalize any requirements due to reporting.

Describe the role of the international Rotarians in this activity and list their specific responsibilities.

- * The Marietta Metro Rotary Club has shaped this grant request through its interaction with Pat MacPherson of MAC Ministries, specifically the development of relevant questions and the gathering of much of the information now present in this grant request.
- * We budgeted funds for this project and raised those funds through a charitable golf tournament held in May 2015.
- * We have participated in international calls with Alejandro Ontiveros Lozano, and exchanged numerous e-mails with members of the Sierra Madre Rotary Club and Pat MacPherson.
- * The Marietta Metro Rotary Club has received pre-approval from Rotary District 6900 for this grant to receive \$31,000 in D6900 District Designated Funds.
- * Marietta Metro Rotary Club members have been named to an implementation team and will consider travel at their own expense to Renacimiento if needed to assist the Sierra Madre Rotary Club in installing the equipment purchased with this grant and helping bring the health clinic operational.
- * The Marietta Metro Rotary Club and its partners (need club names) has committed to publicize this project in their local media and in its Rotary district newsletter.

SUSTAINABILITY

Describe the role that members of the local community will play in implementing your project. What incentives (e.g., compensation, awards, certification, promotion) will you provide to encourage local participation?

Casa Samuel (led by its pastor Eva Zapata) has already been engaging the community by sponsoring the food diner (Casa Samuel A.C.) and the strategy is to continue with the same mechanics for the clinic (Casa Samuel Salud ABP). It has been able to partner with other NGOs and city authorities to obtain funds for operations. Its major incentive is to help those families in need. The community in general will be highly motivated to be able to receive medical treatment at fairly low cost. The community has been participating with labor in many activities involved in the plumbing and construction of the health clinic.

In regards to staffing... We are fortunate in that Dr. Jesus Santos will assist in recruitment of part-time and full-time medical volunteers to staff the health clinic. In particular:

1) The plan is to target opening the clinic one to three days a week at first. It is estimated, that within six months, the clinic

could be operating up to six days a week.

- 2) The staffing vision is as follows: to be staffed and operated through the following partnerships.....
- a. Dr. Jesus Santos who is the current medical director for the medical clinic as well as a member of the board of directors (also known as the Patranado), is employed by the Univ. of Monterrey medical school. He plans to use his network and professional relationships to build a funnel for Student Residents to serve in the medical clinic.
- b. TECH partnership TECH is an acronym for the medical school in Monterrey. MAC Ministries, in speaking with Dr. Santos' boss who is a Dean in the school, believes there is great interest in both formal partnerships and formal studies with the medical clinic. The formal study programs are of great interest to the school due to the size of Renacimiento. They are hoping that through some of the long-term studies that they conduct the school will have both national and international recognition.
- c. Church Partnerships there are two churches in Monterrey that have medical mission efforts residing in each of their congregations. The two churches combined have agreed to hosting 9 medical brigades (medical/clinical mission fairs where a group of medically trained personnel use a 1-2 day event to see 100+ patients). They will use the clinic equipment for these brigades and will also provide health education information as part of the effort.
- d. Social Service partnerships Casa Samuel is currently seeking out government and private social service programs that will staff certain events and programs that will be hosted at the Clinic. The goal is to develop long-term partnerships that can commit to one month a year to contribute US\$10,000. These will be developed over the next several years and combined will be integral to the foundational (sustaining) financial support for the clinic.
- e. Full-Time/Part-Time staff there is a plan to hire two full-time staff members and 2 4 part time staff members within the first year of operations. The budget anticipates US\$2,500 per month for the doctor, administrator, a nurse and a receptionist (based on a 5-day week).
- f. Volunteer staff we anticipate that through the above partnerships, we will encounter individuals who volunteer/commit their time to serving in the Clinic.

Roberto Garza, currently Director of Operations and his mother Pastor Evangelina Zapata will be responsible for the day-to-day operation of the clinic. Dr. Jesus Santos, Cardiologist, as well as Professor at the Medical University of Monterrey is the current Medical Director for the clinic.
